AGENCY FOR HEALTH CARE ADMINISTRATION

On October 27, 2016 the Agency for Health Care Administration (AHCA) submitted the Housing ServicesWaiver Amendment to The

Centers for Medicare &Medicaid Services (CMS). CMS has accepted the application and has posted the Waiver Amendment on its website. As required by federal regulations the amendment must be posted in order to allow for public comment. The public comment period ends December 15, 2016 at which time CMS will make a decision to approve or disapprove AHCA's request. If approved Florida Medicaid will allow qualified Medicaid managed care plans to provide persons with severe mental illnesses and substance abuse disorders transitional housing services, supportive housing services, crisis housing services, and peer support services in AHCA Area 5 serving Pinellas and Pasco Counties and AHCA Area 7 serving Orange, Seminole, Brevard and Osceola Counties. The pilot program is designed to increase coordination and referrals between systems that fund housing and provide behavioral health services.



The Department of Children and Families has posted policy document (Guidance 29) providing direction for managing entities regarding a \$3.5 million project for a transitional voucher program. The voucher program was created to assist individuals in state hospitals who could be discharged if community services and housing assistance was available. Individuals to be served include persons ready to transition from FACT teams, state hospitals, and individuals who are homeless.



Florida State Agencies Legislative Budget Requests

Several state agencies have included some elements of supportive housing programs in their Legislative Budget Requests (LBR) submitted to the Governor for Fiscal Year 2017-18. Governor's staff will be reviewing these LBRs in developing the Governor's budget proposal to the Legislature. The Governor will release his budget late January or early February.

The Department of Children and Families has requested funding for several projects that include funding for services and/or housing assistance for permanent supportive housing as part of the proposal. Proposals include a housing assistance program in Alachua County, increased funding for the managing entity housing initiative, and others. Read more...

The Florida Housing Finance Corporation has requested \$76, 466,138 from the State Housing Trust Funds for State Apartment Incentive Loan(SAIL) Program and \$197,488,597 for the State Housing Initiatives Partnership (SHIP) Program.

The Agency for Health Care Administration has requested \$10.6 million to continue the 1115 Waiver Housing Pilots. (See Agency for Health Care Administration article above)

Resources

HUD published a final rule amending its fair housing regulations in order to protect individuals who experience harassment in housing. The courts and HUD have long considered harassment based on race, color, national origin, religion, sex, family status, and disability (the "protected classes") to be prohibited under the Fair Housing Act. Standards for assessing harassment claims, however, had not been formalized in regulation. To address this lack of standards, the rule adds to the existing regulation a definition the terms "quid pro quo", harassment and "hostile environment", examples of such harassment, specifics about how HUD would evaluate complaints, and clarified standards for "direct liability." Center on Budget Policy Priorities released several articles on housing Alicia Mazzara noted the widening gap between rents and renter income in 2015. Will Fischer cited a new report supporting a tax credit to reduce housing cost burdens for renters. Ehren Dohler described a study finding that housing vouchers are the most effective tool for families seeking to escape the hardships of homelessness. An updated chart shows how federal housing spending is poorly matched to need. Hannah Katch reviews the value of Medicaid as an Essential Partner for Supportive Housing.

A federal report released November 17, 2016 calls for a shift in the way America addresses substance addictions, finding one in seven Americans will face such a disorder. "Facing Addictions in America: The Surgeon General's Report on Alcohol, Drugs and Health marks the first report from a surgeon general dedicated to substance addictions and calling for humane, cost-effective community treatment.

HUD released <u>The 2016 Annual HomelessAssessment Report (AHAR) to Congress</u>. A total of549,928 individuals were homeless on a single night in January 2016, representing a 3% decline in homelessness from January 2015 and a 15% decline from 2007. The report is based on the annual Point-in-Time (PIT) count.Read more ofthis article at NLIHC
